ABSTRAK

Tujuan dari penelitian ini mengenai Kajian Etis-Teologis: Penatalayanan Gereja Di Jemaat KGPM Torsina Motoling. Penelitian ini menggunakan metode deskriptif kualitatif yang di laksanakan di gereja KGPM Sidang Torsina Motoling. Data yang di kumpulkan yaitu melalui observasi dan wawancara kepada sumber data, kepada penatalayanan di gereja baik BPS, PMS dan Gembala.

Dari penelitian yang dilakukan, maka peneliti memperoleh hasil bahwa penatalayanan di KGPM Torsina Motoling belum memaksimalkan tanggungjawab dalam menatalayani jemaat. Penatalayanan di KGPM Torsina Motoling, hanya sebatas memahami tapi untuk tindakan terhadap apa yang di tentukan dalam Alkitab dan Peraturan Gereja KGPMb belum terealisasi secara keseluruhan.

Dari hasil temuan peneliti merekomendasikan kepada penatalayanan untuk memahami dan melakukan secara nyata aturan yang di tetapkan dalam Alkitab dan aturan gereja, baik itu di gereja KGPM maupun setiap gereja. Penatalayanan harus melakukan cara kerja dalam Etika Kristen, sehingga setiap penatalayanan mampu mempertanggungjawabkan setiap perkataan dan tindakan untuk melayani di dalam gereja secara Alkitab dan iman Kristen.
