ABSTRAK

ABSTRACT

The purpose of this writing is to find out a critical historical study regarding the relationship between in-laws and daughter-in-law according to Ruth 1:1-22, especially to analyze the Congregation's understanding of the relationship between in-laws and daughter-in-law at the GMIST Congregation of Bait Zalil Laine.
