

TANGGUNG JAWAB PELAYAN KHUSUS DI JEMAAT GERMITA LI'UNGKALAMATTA NIAMPAK UTARA

ABSTRAK

Tujuan penelitian ini ialah untuk menganalisis tanggung jawab pelayan khusus dalam melaksanakan tugas pelayanan di Jemaat GERMITA Li'ungkalamatta sesuai dengan Tata Gereja GERMITA. Penelitian ini merupakan penelitian deskriptif pendekatan kualitatif yang dilaksanakan di GERMITA Li'ungkalamatta Niampak Utara.

Data yang diperoleh melalui teknik dokumentasi, observasi dan wawancara. Dari hasil analisis dengan pendekatan teologi dan praktis berdasarkan Tata Gereja GERMITA serta teori tanggung jawab pelayanan menurut Yohanes Calvin, diperoleh indikasi bahwa: (1) Sebagian pelayan khusus belum sepenuhnya melaksanakan tanggung jawab sebagai pelayan khusus GERMITA, (2) kelalaian yang dilakukan menimbulkan dampak negatif bagi jemaat, (3) peran pelayan khusus sangat penting dalam menjalankan pelayanan bersama di jemaat.

Dari hasil temuan tersebut maka direkomendasikan untuk pelayan khusus di jemaat GERMITA Li'ungkalamatta Niampak Utara lebih lagi memahami tugas dan tanggung jawab sebagai pelayan khusus dan bagi Badan Pekerja Majelis Jemaat (BPMJ) untuk dapat melakukan pembinaan dan pendampingan berkelanjutan bagi pelayan khusus agar dapat melaksanakan tanggung jawab sesuai dengan panggilan ilahi dan Tata Gereja GERMITA.

THE RESPONSIBILITIES OF SPECIAL SERVANTS IN THE CONGREGATION OF GERMITA LI'UNGKALAMATTA NIAMPAK UTARA

ABSTRACT

The purpose of this study is to examine the responsibilities of servants, specifically in carrying out service duties in the GERMITA Li'ungkalamatta congregation in accordance with the GERMITA Church Regulations. This study is a descriptive qualitative approach study carried out at GERMITA Li'ungkalamatta, North Niampak.

The data were obtained through documentation, observation, and interview techniques. Based on the results of the examination using a theological and practical approach, and grounded in the church order of GERMITA as well as Jhon Calvin's theory of ministerial responsibility, it was indicated that: (1) some special church servants have not fully carried out their responsibilities as GERMITA special servants, (2) the negligence committed has caused negative impacts on the congregation, and (3) the role of special church servants is very important in carrying out the collective ministry within the congregation.

Based on these findings, it is recommended that the special church servants in the congregation of GERMITA Li'ungkalamatta Niampak Utara further deepen their understanding of their duties and responsibilities as special servants. It is also recommended that the Congregational Board of Elders (BPMJ) provide continuous guidance and mentoring for the special church servants so that they may carry out their responsibilities in accordance with the divine calling and the church order of GERMITA.
