**ABSTRAK**

*Tujuan dari penelitian ini adalah untuk mendeskripsikan pemahaman masyarakat Desa Mala Kecamatan Melonguane Kabupaten Kepulauan Talaud mengenai pencemaran laut, Mendeskripsikan apa saja faktor-faktor yang menyebabkan masyarakat Desa Mala Kecamatan Melonguane Kabupaten Kepulauan Talaud melakukan pencemaran itu dan Kajian etis teologi tentang pencemaran laut yang terjadi di Desa Mala Kecamatan Melonguane Kabupaten Kepulauan Talaud.*

*Penelitian ini menggunakan metode penelitian kualitatif deskriptif. Data di kumpulkan melalui observasi, wawancara, dokumentasi. Ditemukan bahwa (1) masyarakat di desa Mala masih kurang memahami apa itu pencemaran laut, buktinya masyarakat masih melakukan pencemaran laut. (2) penyebab pencemaran laut terjadi akibat dari perbuatan manusia yang kurang memperhatikan lingkungan sekitar dan tidak ada penampungan kotoran hewan sehingga kotoran hewan terbuang ke laut. (3) manusia di berikan mandat untuk menjaga lingkungan namun karena keinginan terlalu ingin menguasai makanya terjadi pencemaran laut.*

*Berdasarkan hasil temuan maka di sarankan agar masyarakat di Desa Mala Kecamatan Melonguane Kabupaten Kepulauan Talaud lebih memperhatikan laut dan mengenai masalah kotoran hewan seharusnya membuat kandang. Sebelum memikirkan untuk membuat kandang. Sebelum bertindak sediakanlah penambungan kotoran hewan agar kotorannya tidak terbuang ke laut dan bagi pemerintah desa harus ada ketegasan untuk memberikan sosialisasi kepada masyarakat desa betapa pentingnya melestarikan dan membudayakan laut.*

**ABSTRACT**

*The purpose of this study is to describe the understanding of the people of Mala Village, Melonguane District, Talaud Islands Regency regarding marine pollution, describe what factors cause the people of Mala Village, Melonguane District, Talaud Islands Regency to carry out the pollution and an ethical theological study of marine pollution that occurs in the village. Mala, Melonguane District, Talaud Islands Regency.*

*This study uses descriptive qualitative research methods. Data were collected through observation, interviews, documentation. It was found that (1) people in the village of mala still do not understand what marine pollution is, the proof is that people still do marine pollution. (2) The cause of marine pollution occurs as a result of human actions that do not pay attention to the surrounding environment and there are no animal waste shelters so that animal waste is thrown into the sea. (3) humans are given a mandate to protect the environment, but because they want to control too much, marine pollution occurs due to human actions, attitudes and responsibilities are simply ignored.*

*Besed on the findings, it is suggested that the people in the village of Mala, Melonguane District, Talaud Islands Regency pay more attention to the sea and a regarding the problem of animal collisions, they should make cages. Before taking action, provide a shelter for animal waste so that the faces are not thrown into the sea and for the village government there must be firmness to provide socialization to the village community. How important it is to preserve and cultivate the sea.*
